Elk's Vista Conservation Easement 125+ acres granted in 2022

As our spring letter says, conservation never stops! In 2022 we grew the number of conserved acres in Grand County to 9,310, with the acquisition of the Elk's Vista Conservation Easement.

This easement is a beautiful 125-acre property west of Kremmling, not far from the 2018 Enter Conservation Easement — it was that easement

which encouraged the landowners of Elk's Vista to conserve their own property. Elk's Vista protects wildlife habitat, forested land, and the magnificent viewshed surrounding Kremmling. Thank you to our Board of County Commissioners and the Open Lands, Rivers, and Trails fund for supporting this project and conservation throughout Grand County.

We also continued many of our annual events, including the Wildflower Walk, now at the Jones Creek Ranch Conservation Easement (Himebaugh Gulch) in July, and Songs & Stars at the Daisy Meadows Conservation Easement in August. These are becoming staples of Grand County's summer calendar and we look forward to these events, and more, in 2023!

Among staff changes at the office, we also welcomed Ray Anilionis and Jennifer Kilpela as new board members in June. We are thrilled to have such a strong and supportive board comprised of diverse views and goals to make the land trust a thriving conservation organization.

We also released our new website! The website was made by EcoPixel. It is user-friendly and available in both English and Spanish, and we will continue updating it to ensure it is informational and accessible for all.

CAROLYN HACKMAN EDUCATION FUND

The Carolyn Hackman Education Fund (CHEF) was created with the expressed purpose of "providing financial assistance to Grand County students who are looking to increase their knowledge of land conservation and management, and who wish to carry such knowledge and appreciation into their adult years."

CHLT annually distributes \$2,000 in **scholarships** from CHEF to graduating high school seniors in Grand County. In 2022 we awarded scholarships to: **Madison Moyer, Zackary Niedzwiecki,** and **Katherine Reisberg**. We look forward to seeing them grow as community leaders and conservation professionals!

We are also in an agreement with the Headwaters River Journey in Winter Park, to sponsor the tickets of Grand County children to attend the educational exhibit. In 2022, **301 tickets** were provided for Grand County children from our sponsorship.



CHLT believes the Headwaters River Journey accurately and effectively educates the public on the issues and arguments surrounding water supply and use in Grand County. Our contribution to the exhibit allows for Grand County children to learn the expertly-presented information in an engaging, entertaining environment.
